# Clayton County Conservation Awareness Network Board Meeting – November 9, 2017, 6:30 p.m.

### Treasurer's Report:

- Chris shared that we approx. broke even income: \$2,808; expenses: \$2,740. Need to settle yet with Volga City Opera House they will get half the bar. Noted we will have no expense for the canned beer.
- Once the bills are finalized, the CCCAN checking acct will be up to approx. \$2,000.
- Gary had offered to donate \$500 to make up the revenue shortfall; Joleen moved to decline Gary's generous offer; Sandy second. Passed unanimously.
- Daryl B. shared his proposed financial challenge to CCCAN Board members: Daryl will match BOD donations (by the end of this calendar year), with his max donation being \$500. Details to follow.
- Daryl L. shared that the CC Conservation Board has not budgeted CCCAN funding for the Osborne Pond project.
- Since we have no proceeds from the Volga City fundraiser, we will await the results of Daryl's challenge to determine what CCCAN will present to the CC Conservation Board. Noted that the Osborne pond project is definitely a focus of the CCCAN, however.

#### **Annual Meeting**

- Sandy reported that the Keystone rooms will be set up as double sets of tables, seating 60 guests. Sandy will have access to additional chairs, as needed. Additional tables will be available for perimeter displays and for registration.
- Joleen reported that Gary will be getting information for a Pheasants Forever table. PF, the Farm Bureau,
  CC Energy District, Corn Growers, CC Democrats are all reaching out to their constituents regarding our annual meeting.
- Daryl L. will represent the CCCAN BOD at an informal dinner with Francis Thicke at Fennelly's.
- Bruce Blair will be asked to help set up at Keystone.
- Joleen would like to share pictures of the door prizes in the ads.
- Sandy and Jean Marie will register attendees directly into the database.
- No financial report will be presented. Daryl's introduction will cover CCCAN's impact (where funds are being spent not exact figures).
- No ballots will be needed, as we have two BOD candidates. Joleen plans to take the online form down. Will be a motion that night to cast a unanimous ballot for the two nominees.
- CCCAN bylaws will not be presented at the annual meeting; Board will review these at a later meeting.
